1 Safety Directions

1.1 General Introduction

Description

The following directions enable the person responsible for the product, and the person who actually uses the equipment, to anticipate and avoid operational hazards.

The person responsible for the product must ensure that all users understand these directions and adhere to them.

About warning messages

Warning messages are an essential part of the safety concept of the instrument. They appear wherever hazards or hazardous situations can occur.

Warning messages...

- make the user alert about direct and indirect hazards concerning the use of the product.
- · contain general rules of behaviour.

For the users' safety, all safety instructions and safety messages shall be strictly observed and followed! Therefore, the manual must always be available to all persons performing any tasks described here.

DANGER, **WARNING**, **CAUTION** and **NOTICE** are standardised signal words for identifying levels of hazards and risks related to personal injury and property damage. For your safety, it is important to read and fully understand the following table with the different signal words and their definitions! Supplementary safety information symbols may be placed within a warning message as well as supplementary text.

1.2 Definition of Use

Intended use

- Computing with software
- Recording measurements
- Carrying out measurement tasks using various GNSS measuring techniques
- · Recording GNSS and point related data
- Remote control of product
- Data communication with external appliances
- Measuring raw data and computing coordinates using carrier phase and code signal from GNSS satellites (GNSS systems)

Reasonably foreseeable misuse

- Use of the product without instruction.
- Use outside of the intended use and limits.
- · Disabling safety systems.
- Removal of hazard notices.
- Opening the product using tools, for example screwdriver, unless this is permitted for certain functions.
- Modification or conversion of the product.
- · Use after misappropriation.
- Use of products with obvious damages or defects.
- Use with accessories from other manufacturers without the prior explicit approval of GeoMax.
- Inadequate safeguards at the working site.
- Controlling of machines, moving objects or similar monitoring application without additional control and safety installations.

1.3 Limits of Use

Environment

Suitable for use in an atmosphere appropriate for permanent human habitation. Not suitable for use in aggressive or explosive environments.



Working in hazardous areas, or close to electrical installations or similar situations Life Risk.

Precautions:

 Local safety authorities and safety experts must be contacted by the person responsible for the product before working in such conditions.

1.4 Responsibilities

Manufacturer of the product

GeoMax AG, CH-9443 Widnau, hereinafter referred to as GeoMax, is responsible for supplying the product, including the user manual and original accessories, in a safe condition.

Person responsible for the product

The person responsible for the product has the following duties:

- To understand the safety instructions on the product and the instructions in the user manual
- To ensure that it is used in accordance with the instructions
- To be familiar with local regulations relating to safety and accident prevention
- To inform GeoMax immediately if the product and the application becomes unsafe
- To ensure that the national laws, regulations and conditions for the operation of radio transmitters or lasers are respected

1.5 Hazards of Use

1.5.1 General

A DANGER

Risk of electrocution

Because of the risk of electrocution, it is dangerous to use poles, levelling staffs and extensions in the vicinity of electrical installations such as power cables or electrical railways.

Precautions:

Keep at a safe distance from electrical installations. If it is essential to work in this environment, first contact the safety authorities responsible for the electrical installations and follow their instructions.







N WARNING

Distraction/loss of attention

During dynamic applications, for example stakeout procedures, there is a danger of accidents occurring if the user does not pay attention to the environmental conditions around, for example obstacles, excavations or traffic.

Precautions:

The person responsible for the product must make all users fully aware of the existing dangers.

MARNING

Inadequate securing of the working site

This can lead to dangerous situations, for example in traffic, on building sites and at industrial installations.

Precautions:

- Always ensure that the working site is adequately secured.
- Adhere to the regulations governing safety, accident prevention and road traffic.

CAUTION

Not properly secured accessories

If the accessories used with the product are not properly secured and the product is subjected to mechanical shock, for example blows or falling, the product may be damaged or people can sustain injury.

Precautions:

- When setting up the product, make sure that the accessories are correctly adapted, fitted, secured, and locked in position.
- Avoid subjecting the product to mechanical stress.

NWARNING

Lightning strike

If the product is used with accessories, for example masts, staffs, poles, you may increase the risk of being struck by lightning.

Precautions:

Do not use the product in a thunderstorm.

A DANGER

Risk of being struck by lightning

If the product is used with accessories, for example on masts, staffs, poles, you may increase the risk of being struck by lightning. Danger from high voltages also exists near power lines. Lightning, voltage peaks, or the touching of power lines can cause damage, injury and death.

Precautions:

- Do not use the product in a thunderstorm as you can increase the risk of being struck by lightning.
- Be sure to remain at a safe distance from electrical installations. Do not use the product directly under or close to power lines. If it is essential to work in such an environment contact the safety authorities responsible for electrical installations and follow their instructions.
- If the product has to be permanently mounted in an exposed location, it is advisable to provide a lightning conductor system. A suggestion on how to design a lightning conductor for the product is given below. Always follow the regulations in force in your country regarding grounding antennas and masts. These installations must be carried out by an authorised specialist.
- To prevent damages due to indirect lightning strikes (voltage spikes) cables, for example for antenna, power source or modem should be protected with appropriate protection elements, like a lightning arrester. These installations must be carried out by an authorised specialist.
- ▶ If there is a risk of a thunderstorm, or if the equipment is to remain unused and unattended for a long period, protect your product additionally by unplugging all systems components and disconnecting all connecting cables and supply cables, for example, instrument antenna.

Lightning conductors

Suggestion for design of a lightning conductor for a GNSS system:

1. On non-metallic structures


Protection by air terminals is recommended. An air terminal is a pointed solid or tubular rod of conducting material with proper mounting and connection to a conductor. The position of four air terminals can be uniformly distributed around the antenna at a distance equal to the height of the air terminal.

The air terminal diameter should be 12 mm for copper or 15 mm for aluminium. The height of the air terminals should be 25 cm to 50 cm. All air terminals should be connected to the down conductors. The diameter of the air terminal should be kept to a minimum to reduce GNSS signal shading.

2. On metallic structures


Protection is as described for non-metallic structures, but the air terminals can be connected directly to the conducting structure without the need for down conductors.

MARNING

Incorrect fastening of the external antenna

Incorrect fastening of the external antenna to vehicles or transporters poses the risk of the equipment being broken by mechanical influence, vibration or airstream. This may result in accident and physical injury.

Precautions:

Attach the external antenna professionally. The external antenna must be secured additionally, for example by use of a safety cord. Ensure that the mounting device is correctly mounted and able to carry the weight of the external antenna (>1 kg) safely.

NWARNING

1.5.2 Charger and Batteries

MARNING

Electric shock due to missing ground connection

If unit is not connected to ground, death or serious injury can occur.

Precautions:

▶ The power cable and power outlet must be grounded!





WARNING

Electric shock due to use under wet and severe conditions

If unit becomes wet it may cause you to receive an electric shock.

Precautions:

- ▶ If the product becomes humid, it must not be used!
- Use the product only in dry environments, for example in buildings or vehicles.



Protect the product against humidity.

WARNING

Unauthorised opening of the product

Either of the following actions may cause you to receive an electric shock:

- Touching live components
- Using the product after incorrect attempts were made to carry out repairs

Precautions:

- ▶ Do not open the product!
- Only GeoMax authorised service centres are entitled to repair these products.



Inappropriate mechanical influences to batteries

During the transport, shipping or disposal of batteries it is possible for inappropriate mechanical influences to constitute a fire hazard.

Precautions:

- Before shipping the product or disposing it, discharge the batteries by the product until they are flat.
- When transporting or shipping batteries, the person in charge of the product must ensure that the applicable national and international rules and regulations are observed.
- Before transportation or shipping, contact your local passenger or freight transport company.



Exposure of batteries to high mechanical stress, high ambient temperatures or immersion into fluids

This can cause leakage, fire or explosion of the batteries.

Precautions:

 Protect the batteries from mechanical influences and high ambient temperatures. Do not drop or immerse batteries into fluids.

WARNING

Short circuit of battery terminals

If battery terminals are short circuited e.g. by coming in contact with jewellery, keys, metallised paper or other metals, the battery can overheat and cause injury or fire, for example by storing or transporting in pockets.

Precautions:

Make sure that the battery terminals do not come into contact with metallic objects.

1.6 Electromagnetic Compatibility (EMC)

Description

The term Electromagnetic Compatibility is taken to mean the capability of the product to function smoothly in an environment where electromagnetic radiation and electrostatic discharges are present, and without causing electromagnetic disturbances to other equipment.



Electromagnetic radiation

Electromagnetic radiation can cause disturbances in other equipment.

Precautions:

Although the product meets the strict regulations and standards which are in force in this
respect, GeoMax cannot completely exclude the possibility that other equipment may be
disturbed.

ACAUTION

Use of the product with accessories from other manufacturers. For example field computers, personal computers or other electronic equipment, non-standard cables or external batteries

This may cause disturbances in other equipment.

Precautions:

- Use only the equipment and accessories recommended by GeoMax.
- When combined with the product, they meet the strict requirements stipulated by the guidelines and standards.
- When using computers, two-way radios or other electronic equipment, pay attention to the information about electromagnetic compatibility provided by the manufacturer.

CAUTION

Intense electromagnetic radiation. For example, near radio transmitters, transponders, two-way radios or diesel generators

Although the product meets the strict regulations and standards which are in force in this respect, GeoMax cannot completely exclude the possibility that function of the product may be disturbed in such an electromagnetic environment.

Precautions:

Check the plausibility of results obtained under these conditions.

! CAUTION

Electromagnetic radiation due to improper connection of cables

If the product is operated with connecting cables attached at only one of their two ends, for example external supply cables, interface cables, the permitted level of electromagnetic radiation may be exceeded and the correct functioning of other products may be impaired.

Precautions:

While the product is in use, connecting cables, for example product to external battery, product to computer, must be connected at both ends.

Radios or digital cellular phones







2.3.1 Software Concept

Software upload

The software can be uploaded using Zenith Manager.



Ensure that a microSD card is inserted into the GNSS receiver before starting the upload. Refer to 4.6 Insert a microSD Card.

2.3.2 Power Concept

Use the GeoMax batteries, chargers and accessories or accessories recommended by GeoMax to ensure the correct functionality of the instrument.



Press and hold button for <1 s. Switches the receiver between rover or base mode.

Press and hold button for 3 s.

Updates the base position coordinates when the GNSS receiver is in base mode. The RTK base LED flashes for 2 s. When no position is available, the LED flashes red.

Press and hold button for 5 s.

Connects to the configured RTK base station or NTRIP server when the GNSS receiver is in rover mode. The RTK rover LED flashes for 2 s. No action if a rover mode is not configured.

Button combinations

Function Button ON/OFF Press and hold buttons for 1 s.

The current almanacs stored on the GNSS receiver are deleted, new almanacs are downloaded and the measurement engine is reset. The Position LED flashes red three times.

Press and hold buttons for 5 s.

The Memory LED flashes red quickly three times. The microSD card of the GNSS receiver is formatted. The Memory LED continues to flash red as the SD card is formatted.


Press and hold buttons for 10 s.

	The registry of the GNSS receiver is deleted. Windows CE and Bluetooth communication settings will be reset to factory defaults. The Storage, RTK Base and RTK Rover LEDs flash red. The Position LED flashes yellow quickly three times. After deleting the registry, the GNSS receiver is turned off.

4 Operation

4.1 Guidelines for Correct Results with GNSS Surveys

Undisturbed satellite signal reception

Successful GNSS surveys require undisturbed satellite signal reception, especially at the instrument which serves as a base. Set up the instrument in locations which are free of obstructions such as trees, buildings or mountains.

Steady instrument for static surveys

For static surveys, the instrument must be kept perfectly steady throughout the whole occupation of a point. Place the instrument on a tripod or pillar.

Centred and levelled instrument

Centre and level the instrument precisely over the marker.


4.2 Equipment Setup

4.2.1 Setting up as a Real-Time Base

Use

The following equipment setup is used for real-time base stations. Raw observation data can also be collected for post-processing.

Equipment setup



Equipment setup step-by-step

1.	Set up the tripod.
2.	Mount the tribrach on the tripod.
3.	Ensure that the tribrach is over the marker.
4.	Mount and level the carrier on the tribrach.



Radio settings



To meet country radio licence requirements, the internal UHF radio must be set before use to legally allowed local frequencies as defined by local or governmental authorities. Use of forbidden frequencies may lead to prosecution and penalties.

At the Configuation wizard screen the internal radio can be configured with default channel, protocol type, channel spacing, transmission power and unit ID. Various required frequencies can be entered into the channel table and assigned to a specific channel number.



When using Pacific Crest GMSK protocol between a Zenith16/40 base and Zenith16/40 rover, the **Unit ID** must be set to a different number for each receiver.

Firmware upload

The latest version of the instrument firmware is available from the GeoMax website.

To update the instrument firmware, copy the respective file to the SYSTEM directory on a microSD card and insert it into the GNSS receiver. Refer to 4.6 Insert a microSD Card.

At the **Firmware upload** menu the contents of the SYSTEM directory of the microSD card are displayed. Choose the required file and click **Upgrade** to install the firmware onto the GNSS receiver.

Charging/first-time use

Operating Principles

- The battery must be charged prior to using it for the first time because it is delivered with an energy content as low as possible.
- The permissible temperature range for charging is between 0 °C to +40 °C/+32 °F to +104 °F. For optimal charging we recommend charging the batteries at a low ambient temperature of +10 °C to +20 °C/+50 °F to +68 °F if possible.
- It is normal for the battery to become warm during charging. Using the chargers recommended by GeoMax, it is not possible to charge the battery if the temperature is too high.
- For new batteries or batteries that have been stored for a long time (> three months), it is effectual to make only one charge/discharge cycle.
- For Li-Ion batteries, a single discharging and charging cycle is sufficient. We recommend
 carrying out the process when the battery capacity indicated on the charger or on a
 GeoMax product deviates significantly form the actual battery capacity available.

Operation/discharging

- The batteries can be operated from -20 °C to +55 °C/-4 °F to +131 °F.
- Low operating temperatures reduce the capacity that can be drawn; high operating temperatures reduce the service life of the battery.

5 Care and Transport

5.1 Transport

Transport in the field

5.2 Storage

Product

Respect the temperature limits when storing the equipment, particularly in summer if the equipment is inside a vehicle. Refer to 6 Technical Data for information about temperature limits.

Li-Ion batteries

- Remove batteries from the product and the charger before storing
- After storage recharge batteries before using
- Protect batteries from damp and wetness. Wet or damp batteries must be dried before storing or use
- A storage temperature range of 0 °C to +30 °C / +32 °F to +86 °F in a dry environment is recommended to minimize self-discharging of the battery
- At the recommended storage temperature range, batteries containing a 40% to 50% charge can be stored for up to one year. After this storage period the batteries must be recharged


5.3 Cleaning and Drying

Product and accessories

 Use only a clean, soft, lint-free cloth for cleaning. If necessary, moisten the cloth with water or pure alcohol. Do not use other liquids; these may attack the polymer components.

Damp products

Dry the product, the transport container, the foam inserts and the accessories at a temperature not greater than 40 $^{\circ}$ C [104 $^{\circ}$ F] and clean them. Remove the battery cover and dry the battery compartment. Do not repack until everything is dry. Always close the transport container when using in the field.



Cables and plugs

Keep plugs clean and dry. Blow away any dirt lodged in the plugs of the connecting cables.

Connectors with dust caps

Wet connectors must be dry before attaching the dust cap.
